REQUIREMENTS FOR COMPLETING THESIS

The volume of the manuscript is up to 3 pages, including figures and tables. The number of co-authors is no more than three. Theses must be prepared using the Word for Windows editor. The page format is A4.

Margins: on the left – 2.0 cm; on the right – 2.0 cm; from above - 2.0 cm; from below - 2.0 cm. Interval between lines - 1.0. Font – Times New Roman, 12 pt. The indentation of the first line is 1.25 cm.

The text of the manuscript should be structured according to the scheme:

Authors' initials and surnames are in capital letters in the upper right corner.

The name of the organization where the author works (in Ukrainian (another language of the conference)) - in full, right.

An empty line.

The title of the report (in Ukrainian (another language of the conference)) in capital letters, in the centre (Times New Roman, 12 pt., bold).

An empty line.

Main text. (Times New Roman, 12pt.).

An empty line.

The word “Literature” in the centre (Times New Roman, 12 pt., bold).

An empty line.
